Theme 2: Experience of antenatal care:

- 2.1 In every community women follow certain procedures to ensure the health of their pregnancy. I would like to ask any of you to tell me about your experience with any procedure you followed or care you received while pregnant? Follow up with the women that indicate they got antenatal care from a traditional provider, probe further for reasons, and their experiences? Highlight examples from in-depth interviews for confirmation. Follow up with the women that indicate they got antenatal care at home, probe further for their experience? Confirm emerging issues from the in-depth interviews.
- 2.2 Follow up with women that indicate they got antenatal care at health facility, probe further for reasons for going to a health facility, and their experiences. Ask them to please describe how they choose the health care facility or facilities where they attended pregnancy (antenatal) care? What did they like about their experience with antenatal care? What did they not like? What could be improved, in their opinion? Confirm emerging issues from the in-depth interviews.
- 2.3 Further probe on ANC, please tell me about the interaction, contact or communication that you had with the health care providers or staff during your antenatal care visits. What did the providers tell you? What questions did you ask?

- 2.4 Further probe on ANC, would you go back to this facility for antenatal care with your next baby? Would you recommend this facility to your friends and family? What makes you say that?

- 3.3 Please tell me about the interaction, contact or communication that you had with the health care providers while you were at the health facility during your labour and delivery. Confirm emerging issues from the in-depth interviews What did the providers tell you? What questions did you ask? Can you describe to me again what you can remember about the attitude of health workers during your labour and delivery?
- 3.4 Please think again about your facility delivery experience, describe to me how comfortable you were during labour and delivery? What was done to make you comfortable? If not comfortable, explain to me why? Think again about your facility delivery experience, describe to me how clean the facility and the delivery room were? Did it matter to you? Can you explain to me why?
- 3.5 Try to recall your birth experience, what was important to you? How did the experience compare to your expectations? Would you feel comfortable delivering outside of a hospital? Why or why not?
- 3.6 Who accompanied you to the facility? Was the person able to stay with you in the facility, delivery room? How did you like this? Please tell me more?
- 3.7 Would you return to the health facility where you had your last baby? What makes you say that? Would you recommend it to friends and family? What makes you say that?
- 3.8 If you have another pregnancy after this one, would you want the same thing or something else? Why?

Theme 4: Experience of care after delivery:

- 4.1 How long were you at the facility? Did that bother you or not? Please explain why you said so?

- 6.4 Does it matter or not to women in labour if they go to deliver at a health facility and the providers use harsh or rude language (e.g. ..."if you don't provide hand gloves you are on your own" "...if you will not cooperate and push this baby out I will be going home to leave you with the cleaners")? - 6.5 Does it matter or not to women in labour if they go to deliver at a health facility and the providers use judgmental or accusatory suggestive of assigning blame of poor labour outcome (e.g. ..."if you don't push you will kill your baby" "it is your fault for not coming to the hospital early")? - 6.6 Does it matter or not to women in labour if they go to deliver at a health facility and the providers failed to communicate the progress their labour or procedures that he/she will do to them or their baby needed? Why, please explain what you mean?
- 6.7 Does it matter or not to women in labour if they go to deliver at a health facility and the providers did not allow them to ask questions during labour or delivery? Why, please explain?
- 6.8 Does it matter or not to women in labour if they go to deliver at a health facility and the providers failed to maintain their physical privacy for example with a screen or cover their body during labour and delivery? Why, please explain what you mean? What about discussing their information very loud that other people could hear, how will that make you feel?
